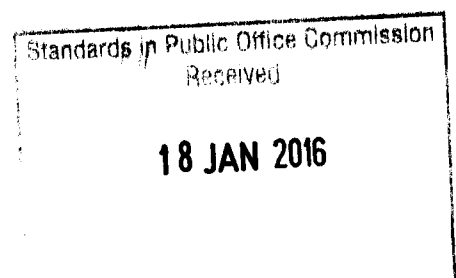

v) Donations by non-registered corporate donors in excess of €200

It is prohibited to accept a donation exceeding **€200** in value from a corporate donor unless the corporate donor is registered in the Register of Corporate Donors maintained by the Commission **and** a statement is made on behalf of the corporate donor (and furnished with the donation to the donee) confirming that the making of the donation was approved by the corporate donor.
