Foreword

I am pleased to furnish this report to the Chairman of Dáil Éireann (Ceann Comhairle) in accordance with the provisions of section 4(1) of the Electoral Act 1997, as amended (the Act).

The Election Expenses Statements/Statutory Declarations referred to in the report were furnished to the Standards in Public Office Commission (the Commission) pursuant to section 36 of the Act. Donation Statements/Statutory Declarations referred to in the report were furnished pursuant to section 24 of the Act, while the Certificates of Monetary Donations/Statutory Declarations and statements from financial institutions were furnished pursuant to section 23B of the Act.

Chapter 1 Introduction

This report concerns the Commission's supervision of the European Parliament elections of 23 May 2014 and is being furnished to the Ceann Comhairle in accordance with section 4(1) of the Act.

As provided in Parts IV and V of the Act, all election agents at the election were required, within 56 days after polling day, (i.e., by 18 July 2014) to furnish the Commission with:

• an Election Expenses Statement/Statutory Declaration;

and all unsuccessful candidates were required to furnish the Commission with:

- a Donation Statement/Statutory Declaration; and
- a Certificate of Monetary Donations/Statutory Declaration and bank statement.

This report concerns the statutory returns furnished in respect of the candidacy of the forty one candidates at the European Parliament election 2014.

Section 4(1) of the Act provides that the Commission shall consider every statement furnished to it and may, where it considers it appropriate to do so, furnish a report to the Ceann Comhairle on any matter arising in relation to Donation Statements and Election Expenses Statements furnished to it under the Act.

In considering the statements referred to above, the Commission had regard to the Guidelines it issued in advance of the European Parliament election and it examined all the statements to ensure compliance with the Guidelines and the legislation. Following an examination of the statements received, the Commission is satisfied that:

- no candidate exceeded the expenditure limit,
- no candidate received a reimbursement of election expenses in respect of expenditure that was not an election expense and
- that no prohibited donations were disclosed by candidates.

In accordance with section 4 of the Act the Commission's report must be laid before the Houses of the Oireachtas.

The relevant details relating to donations and expenses in relation to the election are given in Chapter 3. Political parties incurred election expenses nationally of \in 129,764 and expenditure in relation to individual candidates of \in 1,545,082. Election agents incurred expenses totalling \in 1,207,483. The reported total of all the election expenses was \in 2,882,329 and is detailed in Chapter 3. Only six of the forty one candidates reported the receipt of donations, totalling \in 23,649.

Chapter 2 General information relating to the European Parliament Election

The Commission published Guidelines for the European Parliament election 2014 for candidates, election agents and national agents and issued a copy to each candidate, election agent and national agent. The Guidelines set out the requirements relating to various matters such as the acceptance and disclosure of donations, prohibited donations, political donation accounts and spending at the election. Section 21 of the Electoral Act provides for the reimbursement of election expenses to qualified candidates. In order to qualify, candidates at a Dáil bye-election must either –

- 1) have been elected, or
- 2) if not elected, have exceeded, at any stage of the counting of votes at the election, one quarter of the quota.

Twenty five candidates at the election qualified for a reimbursement of their election expenses. The maximum amount which may be reimbursed to a qualified candidate is the lesser of €38,092.14 or the actual expenses incurred by/on behalf of the candidate. The relevant details are set out in Chapter 3.

The Standards Commission must certify to the Minister for Finance that a candidate is eligible for a reimbursement of his/her election expenses and that an Election Expenses Statement, completed in accordance with the provisions of the Act and the Guidelines published by the Standards Commission, has been furnished to the Standards Commission in relation to the candidate. The Standards Commission is also required to notify the Minister for Finance of the expenditure incurred by each candidate and of the reimbursement due in each case.

Chapter 3 Donations and election expenses disclosed

Total donations disclosed amounted to €23,649. Successful candidates were not required to disclose any donations which they may have received. Such disclosures will be required of successful candidates in their annual returns at end of 2014. The total of election expenses (election agent plus national agent plus party "national" spend) reported was €2,882,329. The tables below give all the relevant details relating to donations and expenses in relation to the election.
